3 Literature review

The literature review starts with a detailed introduction into the principle of Creative Commons and their licences, mainly to make a reader of the thesis familiar with the basic terms and concepts which are further used in the text.

Creative Commons consortium defines itself as "a nonprofit organization that helps overcome legal obstacles to the sharing of knowledge and creativity to address the world's pressing challenges" (Creative Commons, 2021b). Creative Commons provides several types of copyright licences which are free of charge which are available to the authors, including a public domain license. Via the licences the authors waive some rights for the benefit of public. The main principle is some rights are reserved instead of all rights are reserved to protect the intellectual property of authors and support free culture in the era of digital and information age.

As it was mentioned, there are several options of Creative Commons Licenses³, they differ in the rights to the copyrighted work which are provided for free to the public, to any user. Following list is based on the descriptions of the particular licence options at the official Creative Commons website (Creative Commons, 2021a):

CC BY – Creative Commons Attribution. This is the most permissive licence. It allows users to distribute, adapt, remix and build upon the material³, and use it for any use including commercial use. There is only one condition: credits must be given to the creator.

CC BY-SA – Creative Commons Attribution ShareAlike.⁴ This licence allows users to distribute, adapt, remix and build upon the material³, but if users edit the original piece of work, they must share it under a same or similar license and give credits to the author.

CC BY-NC – Creative Commons Attribution NonCommercial.⁵ This license allows users to distribute, adapt, remix and build on the material³ only if it is used for non-commercial use and the credits are given to the author.

CC BY-NC-SA – Creative Commons Attribution NonCommercial Share Alike.⁶ This license is a combination of the two previous licenses.

CC BY-ND – Creative Commons Attribution No Derivatives.⁷ This license allows users to copy and distribute the material, but they cannot adapt it.

CC BY-NC-ND – Creative Commons Attribution NonCommercial No Derivatives.⁸ It is the most restrictive license. It combines the previous two licenses.

Mallalieu (2019) discusses the Creative Commons licenses⁹ for educational materials to be used repetitively in the higher education institutions (HEI)⁹ in United Kingdom. The author the mentions Copyright, Designs and Patents Act 1988 (CDPA), the Higher Education Funding Council for England (HEFCE) policies, the Research Councils (RCUK) – now part of UK Research and Innovation (UKRI).⁹ The author bases the research on the 2017 Monitoring the transition to open access report⁹ (Mallalieu, 2019).
